2. 11. The Scope of the Application Right Pursuant to the Article 11 of the KVKK

The Applicant can apply to Bemas Metal to request the below listed information:

1) Learn whether his/her personal data has been processed,

2) If yes, request information about how his/her personal data is processed,

3) Learn the purpose of processing his/her personal data and whether it is used for the intended purpose,

4) Have information about third parties in the country and abroad with his/her personal data has been shared,

5) Request correction/amendment if his/her personal data is processed incorrectly or incompletely and that such correction/amendment is informed to the third parties to whom his/her personal data has been transferred,

6) Request that his/her personal data is deleted or removed or made anonymous despite being processed in accordance with the KVKK and other applicable regulations if the reasons for his/her data to be processed no longer exist and that these actions are informed to the third parties with whom his/her personal data has been shared,

7) Object to any unfavourable outcome for the applicant due to the reason that his/her processed data is analysed solely by automated systems,

8) Claim damages in the event that the applicant incur losses due to the reason that his/her personal data is processed illegally.

3. Application Method

Pursuant to the first paragraph of the article 13 of the KVKK, any application to exercise these rights should be in writing and signed or through other methods described by the Personal Data Protection Board ("Board").
